MAY OIL PRODUCTION BEST IN AUSTIN'S ASX HISTORY

- TOTAL WELL OUTPUT EXCEEDS 5000 BARRELS OF OIL FOR MAY 2011
- COMMENCEMENT DISCOVERY WELL STABLE AT 130 BOPD
- NIOBRARA SHALE ACQUISITION IMMINENT
- AGGRESSIVE EAGLE FORD SHALE EXPANSION ON TRACK

The Board of Austin Exploration Limited (ASX: "AKK") - on behalf its wholly owned US subsidiary Aus-Tex Exploration Inc - is pleased to report to shareholders that it has just achieved its best monthly production and revenue month since the Company was listed on the ASX in July 2006.

The record May 2011 performance – achieved as Austin prepares to embark on a major USA Oil & Gas Shale exploration programme – provides the company with a stronger cash flow and production base which will allow for newly raised capital to be invested directly into the exploration and development of its recently acquired shale assets in the US.

Austin is pleased to report that it remains on track with its goal of acquiring a total of 5000 acres of Eagle Ford Shale prospects by the end of July 2011.

Good progress continues to be made with acquiring Niobrara Shale acreage in North Western, USA. Austin looks forward to updating the market on this acquisition once shareholder approval for funding the acquisition has been approved at the company's upcoming EGM on the 17th June.

Total production from the company's USA operations is continuing to increase following the record May 2011 performance which saw total well output of over 5000 barrels, generating revenues for Aus-Tex of over \$200,000 for the month.

"Our Aus-Tex Exploration team is to be commended on such continued achievements," Mr Guy Goudy, President of the USA-based AusTex, said today.

"We also congratulate our Business Unit Managers responsible for the respective areas," Mr Goudy said.
