Significant New Prospect Acquired

Austin Exploration Limited ("Austin") (ASX code: AKK) today confirmed that it has entered into a farm-in agreement for a 640 acre lease, geographically located in the most prolific oil and gas producing area of South Texas, US.

Austin has acquired a 25% working interest and an 18.75% net revenue interest in this prospect.

David Schuette, Austin Managing Director, said that securing a lease in this established oil producing area is exciting for Austin and he's looking forward to beginning drilling operations.

"Kenedy County is a proven hydrocarbon producing area with excellent accessibility," Mr Schuette said.

"Our farm-in agreement represents a great opportunity for Austin and we plan to commence drilling operations in the next 30 days. This prospect has the potential to bring immediate positive impact to the company. It also represents one of the better risks vs. reward ratios that Austin has participated in. This prospect is being drilled by the operator via a turn-key drilling agreement, therefore eliminating any cost over-run exposure while guaranteeing that the operator will hit target depth at a fixed cost."

Estimates of the amount of natural gas believed to be recoverable from known area prospect reservoirs under existing economic and operating conditions are 6 BCFG - 9 BCFG for the project giving Austin between a 1.12 BCF and 1.687 BCF potential.

The lease is situated in the R. Ramirez Survey, approximately 17 miles east of Sarita in Kenedy County, Texas. An approximate total depth of 7100 feet subsurface should be sufficient to adequately test the Marg Frio formation located there.

The company advises that more information will be announced as the drilling and testing of this prospect begin.


