Potential Pay Discovered, Austin Increasing Working Interest

Austin Exploration Limited ("Austin") (ASX code: AKK) today advised that seven feet of potential pay has been indentified from log and side wall core analysis in the sands located at 5,500 feet of the Lewis Louisiana Properties #1 (Jeter Branch) well.

The company also announced that it has become the official operator of this property and is currently finalising a larger working interest in the prospect.

David Schuette, Austin Managing Director, said: "We are encouraged by these log results and now have a production rig ordered to perforate and test these identified zones.

"In anticipation of the production testing program, we are now in the process of setting 5½ inch casing to a target depth of 6,300 feet.

"After reviewing the data available to us the company has also decided to become the official operator of this prospect and increase our working interest percentage from 30% to 50%" he said.

The Jeter Branch prospect is located in Caddo County, Louisiana, US, and is designed to test Middle and Upper Cretaceous reservoirs down to 5450 feet. The well is substantiated by good subsurface control and two 2-D seismic lines.

The prospect is surrounded by production facilities less than 2 miles away and the drill site is a high, dry, land location. Gas pipelines are located approximately 7000 feet from the well location.

Statement of Working Interests

Austin Exploration currently owns a 30% working interest in this prospect.
